May is Water Awareness Month

May is Water Awareness Month, but with a few tips, residents can be water-wise all year round. Here are a few pointers to help your plants and lawn thrive during the hottest summer months:

Plants


- Choose drought tolerant plants. To see the many choices available, take a walk around the planted areas in Bernal Community Park or visit trivalleywaterwise.com for more ideas
- Reduce the amount of watering and provide for some type of vegetation around plants
- Reduce the number of watering days,

but add one additional watering cycle to one of those days.

Lawn

- Water less frequently for longer period of time
- Water when the sun goes down
- Mow less frequently and never cut more than 1/3 of leaf blade at one time.

Newest City Trail Opens up New Views



The City recently announced the completion of the first phase of the Vineyard Avenue Trail Project, originally envisioned as part of the 1999 Vineyard Avenue Corridor Specific Plan (VCSP). The VCSP stated that after the new Vineyard Avenue was constructed, the original avenue would be closed to vehicular traffic and converted to a pedestrian, bicycle and equestrian trail. The VCSP served as the primary land use and infrastructure guide for the development of roughly 384 acres in the Vineyard Avenue Corridor area, located along Vineyard Avenue in southeast Pleasanton.

The trail, located between Vineyard Terrace and Heinz Ranch Court, was converted into a bike trail, and includes a paved asphalt trail, and an unpaved trail on either side that is suitable for equestrian use. Funding for the project was made available through the Vineyard Avenue Specific Plan fee collected from housing developers within the plan boundaries.

Pleasanton Police Look Forward to National Night Out

The Pleasanton Police Department is looking forward to this year's National Night Out, which is an annual crime and drug prevention event held in over 16,500 communities across the country. Last year Pleasanton community members hosted 45 parties in Pleasanton. Gatherings can be small or large, but no matter the size, every party fosters a genuine connection between residents and the Pleasanton Police Department and other participating partners, from the CHP, elected officials and the local fire department.

Working with Community to Bring Downtown Vision into Focus

City-owned

In 2015, the City Council appointed the Civic Center/Library Task Force of citizens to explore options for a potential new civic center. The Task

Force met for approximately one year and focused on developing a master plan for a new Civic Center/Library that could serve the community for the the next 30 to 50 years. Part of their work involved reviewing previous Civic Center/Library master plans, taking field trips to nearby civic centers and libraries to see what worked well in other cities, and hearing a presentation from a library futurist, who helped the Task Force determine what considerations were important when planning for a library that needed to serve the community over the next three to five decades.

Based on the input received from the community, the Task Force recommended relocating the Civic Center/Library to the Bernal property (adjacent to the Bernal Community Park) to offer a larger, more contemporary library in a peaceful, meadow-like setting; provide a muchneeded community center with a large multi-purpose room, social hall and meeting rooms; and increase efficiencies by consolidating all City offices under one

In November 2016, the Council accepted the Plan put forward by the Task Force with the understanding that relocating the existing civic center and library will require a vote of the people since the Bernal property had been previously designated in 2006 as the site for a cultural and performing arts center.

With the 2010 opening of the Firehouse Arts Center, in combination with shows at the Amador Theater, the need for yet another performing arts center has diminished, which is why the Task Force recommended the civic center relocation as their preferred alternative. The Council also agreed to revisit the Plan following the completion of the DSP update.

In January 2017, the City Council assembled the Downtown Specific Plan (DSP) Task Force to update the 2002 Downtown Specific Plan and create a 20-year vision for downtown Pleasanton, with an eve toward improving downtown while simultaneously preserving its historic, small-town character. An important element is a study of the options for possible redevelopment of the existing civic center area that currently houses City offices and the library. A conceptual plan has been developed that re-envisions the site as a lively entertainment and culture center including a new town square, boutique hotel, parking structure, and a mixture of commercial and modest residential uses. The Plan is still in draft form. The DSP Task Force has also discussed ways to improve the streetscape for Main Street and other key downtown streets, such as redesigning Division Street (between Main Street and Railroad Avenue) as a pedestrian-only street; promoting appropriate residential and commercial infill; and diversifying uses along streets like Old Bernal and Peters Avenue that transition between the commercial center and residential neighborhoods.

The Downtown Specific Plan was adopted in 2002, and Pleasanton has changed since then. Because communities change and evolve over time, cities must continually revisit and update their guiding documents to ensure they reflect the city's current needs.



Progress on Measure I1 Modernization Projects



As the District makes progress on voterapproved Measure II bond projects, the Board of Trustees authorized \$11.5 million to replace temporary classroom facilities and address safety issues.

\$10 million will be used to replace portables at Amador Valley and Foothill high schools, which were installed as temporary classroom structures, some as far back as 1996. The remaining \$1.5

million will be used for much needed fencing at Mohr Elementary and Fairlands Elementary schools, and Harvest Park Middle School, all of which have classrooms that currently open to the outside of the school
