APPROVAL PROCESS

Zoning Approval

For verification of allowable business use at the desired location. Zoning approval is required prior to issuance of a business license. Special restrictions and conditions apply to businesses conducted in a residence. Conditional Use Permits from the Planning Commission may be required for certain businesses and may take up to two months to process.

Some businesses must have police clearance before applying for zoning approval or a business license. Examples of businesses that require such approval are: massage therapy, bingo games, or taxi cab service.
