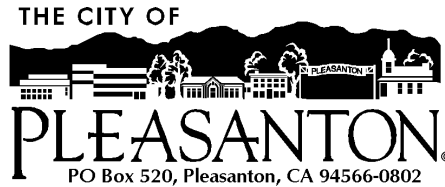


PLEASE NOTE CHANGE IN VENUE FOR APRIL 29th NEIGHBORHOOD MEETING



Dear Property Owners, Residents, and Interested Parties:

As you may know, the City of Pleasanton is in the process of preparing the East Pleasanton Specific Plan.

The East Pleasanton Specific Plan will serve as a detailed extension of the Pleasanton General Plan for a 1,110-acre eastern area of Pleasanton and unincorporated Alameda County. The purpose of the Specific Plan is to guide and coordinate the basic land use pattern, development and design, roadways and other public infrastructure, environmental protection, financing, and implementation requirements for development of the Plan Area.

Three Neighborhood Meetings will be held to receive comments on the Draft Specific Plan. While each of these meetings is intended to be focused on particular neighborhoods, all three meeting dates and times are listed in this notice to maximize public input and provide flexibility for attendance. The Neighborhood Meetings will be followed by a Community-wide Meeting and subsequent Planning Commission and City Council Meetings, allowing for extensive community input.
