TERMS AND CONDITIONS APPLICABLE BETWEEN PARENT/GUARDIAN/SWIMMER AND PLEASANTON PIRANHAS

THE PARENT/GUARDIAN/SWIMMER declares and is aware that:

1. The swimmer is physically and medically fit to proceed with the normal routine of swim practice addressed by the coaches.
2. The parent/guardian/swimmer does hereby agree to follow any programs and or training sessions as may be provided and insisted on by the coaches.
3. Swimmers signing up with Pleasanton Piranhas are "deep water safe" , able to confidently perform at least two of the four official swimming strokes, and complete a distance of at least 25 yards.
4. Due to insurance purposes, NO parent/guardian/amateur, other than the Pleasanton Piranhas swimmer, coaches and pool staff will be permitted in the training area and on pool deck during practice hours.
5. **PLS Piranhas Summer Fees**
 - 5.1 On affiliation to Pleasanton Piranhas, a non-refundable full payment is due before the first day of practice.
 - 5.2 The 2019 summer program will run from Tuesday, May 28th through Saturday July 21st .
 - 5.3 The Pleasanton Piranhas fee does not include any amount toward meet entries, pool space fee (if applicable) or any other such fees, which are due and payable to Pleasanton Piranhas.
 - 5.4 Registration, coaching, kit, meet or any other fees must be paid by means of either: Check, Electronic Transfer or Direct Deposit.
 - 5.5 No cash will be accepted by any Pleasanton Piranhas staff.
6. If the parent/guardian/swimmer is transferred out of Pleasanton and/or surrounding areas, gives up swimming, or moves to another team, written notice is required and clearance will be given when the account has been settled.
7. If any information on the completed affiliation form changes at any time, it is the responsibility of the parent/guardian/swimmer to inform Pleasanton Piranhas in writing.
8. **Swim Meets & Volunteer work**
 - 8.1 The parent/guardian/swimmer is committed to assist at swim meets if and when requested. In the event of the parent/guardian/swimmer not being available for the designated duty, responsibility rests on the parent/guardian/swimmer to make arrangements for a replacement.
 - 8.2 No parent/guardian/swimmer may approach any meet officials with any grievances. The parent/guardian/swimmer may only run meet queries by the Pleasanton Piranhas team manager.
 - 8.3 All swimmers will be required to wear the Pleasanton Piranhas kit when participating at any meet under Pleasanton Piranhas. Full Pleasanton Piranhas attire is to be worn for award and or medal presentations.
 9. Pleasanton Piranhas Coaches, Staff and Dolores Bengtson Aquatic Centre and staff , and the City of Pleasanton and staff, will not be liable for any damage or loss of property; accident and or injury before, during and after any meet, practice or social event.
 10. Should any parent/guardian/swimmer not conform to the rules as laid down by Pleasanton Piranhas, or if any parent/ guardian /swimmer does not comply with any rules and/or instructions as laid down by Pleasanton Piranhas, or any parent/guardian/swimmer dishonours the Summer League Affiliate, then the parent/guardian/swimmer can be expelled at the sole discretion of Pleasanton Piranhas.
