## RFQ, Citywide Programmatic Review of Asset Management Integration

This addendum is hereby made a part of the Request for Qualifications (RFQ). It shall be the responsibility of the prospective consultant to inform any affected sub-consultant of the content of this addendum.

The RFQ documents are modified/clarified as follows:

**1.01 Refer** to the Cover Page and the Request for Qualifications Notice section:

Clarification that the City Engineer and Engineering Division is located in the City offices at 200 Old Bernal Ave, which is where deliveries are accepted. U.S. Mail is received care of P.O. Pox 520.

**1.02 Refer** to the Description and Background section, Project Background paragraph:

Clarification that some City divisions, such as Streets and Utilities, have fairly complete asset data with condition assessments and asset planning. The Maintstar software is the computerized maintenance management system with fields for condition assessments and life cycle risk that are underutilized currently. The geographic information system (GIS) uses ArcGIS software.

**1.03 Refer** to the Scope of Services section, Phase 1 Services paragraph:

Clarification that the City is open to alternative and customized solutions as one of multiple recommendations that take into account the project schedule, complexity to implement, longevity of solution, and maintenance/update costs.

**1.04 Revise** Appendix A – Proposal Requirements, items 9. Contract Agreement and 10. Exceptions and Affirmations to this RFQ:

### 9. Contract Agreement

Replace the first sentence:

The Consultant shall indicate that it has read the City's Sample Contract Agreement included as Attachment 1; and shall identify any issues or needed changes. The top ranked firms will have the requested changes reviewed by the City's legal department prior to opening the cost proposals. Modifications deemed unacceptable by the City may result in the submission considered nonresponsive.

#### 10. Exceptions and Affirmations to this RFQ

*Replace the first sentence:* 

The Consultant shall certify that it takes no exception(s) to this RFQ, with the understanding that the Sample Contract Agreement is addressed in Item 9 above.
