Questions and Answers:

- a) Question: Can the City provide the total mileage of sidewalks, number of bus stops, and signalized intersections?

Answer: There is approximately 360 miles of sidewalk, 266 bus stops, and 125 signalized intersections in the City of Pleasanton.

- b) Question: Will employee areas be included in the assessments of the facilities?

Answer: No, not all areas. Employee areas in each facility that do need to be evaluated are: i) Ingress and egress routes to emergency exits and access routes to & from staff assembly areas. ii) conference rooms, iii) break rooms, and iv) restrooms.

c) Question: Has the due date changed?

Answer: Yes.

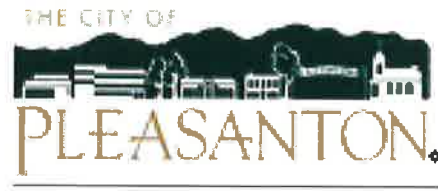
