



**REQUEST FOR PROPOSAL – Addendum #2
FOR
CITY OF PLEASANTON
QUIET ZONE**

**RFP issue date - October 15, 2025
RFP Submittal Deadline – November 13, 2025 (4:00 PM PST).**

The following Addendum is in reference to questions submitted via email by the 4:00 p.m. deadline on October 31, 2025. Section II, Instruction to Proposers, subsection D.

Addenda/Clarifications The original Request for Proposal (RFP) asked that “Questions or comments regarding this RFP must be put in writing and must be received by City of Pleasanton no later than 4:00 p.m. Pacific Standard Time on Friday, October 31, 2025. Correspondence shall be addressed to the Designated Point of Contact.”

Addendum #1 was issued on October 22, 2025, to provide Attachment A, which was referenced in Section VII Proposal Format and Content, but not included in the original proposal document.

Please take note that only questions submitted by the deadline will receive a response. Below, are those questions followed by their response.

Question 1: Are we allowed to use the City’s logo in our proposal?

Response 1: Yes, the City logo may be used as part of the submitted proposal.

Question 2: We did not see the “Proposal General Information Form (Attachment A)” within the RFP or posted on Bidnet. Where can we find this?

Response 2: The City uploaded the Proposal General Information Form (Attachment A) to Bidnet on October 22nd.

Question 3: Please confirm that we can submit this proposal via email instead of submitting five hard copies and one electronic copy on a USB (or does the City want all three: email, hard copies, and USB?)

Response 3: Yes, this proposal can be submitted via email instead of the 5 hard copies and USB. The City does not need email, hard copy, and USB.

Question 4: With the tight turnaround for Q&A and proposal delivery, would the City consider providing a one-week extension to accommodate questions being answered on November 7 to allow us enough time to adjust our responses?

Response 4: The City recognizes the compact schedule of this RFP; however, a one-week extension would add more than a month to the contract award timeline due to the limited number of City Council meetings in December/January.

Question 5: You indicate that interviews could be held the week of November 17. Do you anticipate that interviews will be in person or virtual?

Response 5: The proposers will be given the option to choose between in-person and virtual interviews.

Question 6: Is the \$175,000 budget inclusive for all services outlined in the RFP – from planning through design?

Response 6: Yes. The City acknowledges that the Quiet Zone process involves several stages. The intent of this RFP is to hire a consultant who will, by the end of the contract, deliver the City with a fully implemented Quiet Zone. The \$175,000 contract maximum includes planning, design, and any additional services required after construction completion to fully implement the Quiet Zone. While there are likely multiple SSMs that can be applied to the crossings, the proposer should include the design of typical median barriers at each of the four crossing locations (construction of improvements will be completed under a separate contract).

Question 7: Please clarify the scope of the design task. Does this task include utility coordination, permitting, project manual development, bidding support, etc.?

Response 7: As noted in Response 6, the City acknowledges that a diverse set of SSMs is available for use to meet the SSM requirements. The City's expectation is that standard median islands will be sufficient to meet the SSM requirements, and the scope of the design task would be inclusive of all elements needed to design this type of SSM. The cost proposal that will be submitted separately will need to include the cost for the design of SSM median barriers at each of the 4 crossing locations.

All other items of work in the proposal document remain unchanged. Acknowledgement and a signed copy of this Addendum shall be included in the Proposal.
