

ADDENDUM NO. 3 RECYCLABLE MATERIALS POST-COLLECTION PROCESSING SERVICES Project No. CMO 24.100

This Addendum No. 3 is hereby made a part of the project contract documents. It shall be the responsibility of the proposer to inform any affected sub-bidder of the content of this Addendum.

The City of Pleasanton received the below questions related to this Request for Proposals (RFP) before the proposer question cutoff date of September 30, 2024. The City's answers immediately follow each proposer question. Questions are grouped by topic and, occasionally, multiple questions are answered with a single response.

MODIFICATIONS/CLARIFICATIONS:

In conducting due diligence to address questions related to this RFP, the City has identified significant discrepancies in the tonnage information presented. Please note that this information directly impacts the assumptions related to question 46 in Addendum #2. Historically, PGS marketed approximately 5,000 tons annually, but has been collecting and processing approximately 11,000 tons annually. We anticipate that the selected provider will achieve a higher recovery rate and market a significantly larger portion of these materials. We believe the current residue rate is not due to contamination, but rather a product of the performance of the facility. In relation to the rate proposal form, the City has revised the form for the proposer to indicate value based on 11,000 tons delivered for processing annually, derived from the 2023 data presented in Addendum #2.

QUESTIONS AND ANSWERS

- Q1. Is the city providing cost forms for the bidders to submit for the RFP?
- Q2. Can the City provide an excel version of the rate proposal form?
- Q3. Could the City provide a sample calculation showing how market indices (Revenue Share bullet #2) and the City's allocation and facility performance (Revenue Share bullet #3) are translated into a Revenue share amount for year one and year two?

ANSWER: The City has developed a comprehensive rate form in Excel, which will be sent as an attachment via email to all parties on the interested parties list. We would like to highlight that, based on the revised data provided for year 2023 in response to questions 9-12 in Addendum #2, proposers are asked to prepare and respond to the rate proposal form using an estimated 11,000 tons delivered for processing. Please ensure that your responses reflect this updated tonnage estimate. Additionally, the provided excel schedule illustrates the calculation and each year this would be recalculated using then current tonnage, material characterization, and commodity values. Those variables will result in a different calculation annually.
