

CITY OF PLEASANTON REQUEST FOR QUALIFICATIONS NEWSPAPER OF GENERAL CIRCULATION FOR PUBLICATION OF LEGAL NOTICES

1. BASIS OF AWARD

Any contract awarded as a result of this Request for Qualifications (RFQ) will be based on the evaluation of all proposals using the specifications outlined in this RFQ.

The City of Pleasanton reserves the right to decide whether a proposal does or does not comply substantially with the specifications; to accept, reject, or negotiate modifications in any terms of vendor's proposals or any part thereof; and also to waive any irregularity, informality, or noncompliance with or any non-response to the proposal or any part thereof.

2. SUBMISSION OF PROPOSAL

Proposals must be submitted in electronic format using the form attached as Exhibit 1 by email to the City Clerk's Office at PleasantonCityClerk@cityofpleasantonca.gov.

Proposals must be received no later than 2:00 p.m., Tuesday, June 10, 2025.

3. STATUS OF NEWSPAPER

Each proposal shall submit proof that it is submitted on behalf of an established newspaper that is an adjudicated newspaper of general circulation within the City of Pleasanton at the time of submission and for the term of the contract in accordance with Government Code Section 6008.

4. PROOFS AND AFFIDAVITS OF PUBLICATION

Proofs must be provided for the City's review and final approval with at least 24 hours' notice prior to print deadline.

Upon completion of each publication, two Affidavits of Publication must be delivered to the City within 7-10 business days and are required for payment of invoices.

5. RATES

The rates proposed to be charged shall be designated for each column inch for a first publication, each column inch for a second publication, and each column inch for all additional publications. Proposals shall indicate that the rates proposed to be charged to the City do not exceed the customary rates charged by the newspaper for the publication of legal notices of a private character.

6. RATE QUOTATIONS

PART 1

In order to determine appropriate format for notices, submit rates on the basis of a six column and a ten column format. Attached **Exhibit 2A** is a sample public hearing notice. Please submit a quotation for this publication.

PART 2

Submit a rate proposal for the attached block ad **(Exhibit 2B)**, which is screened, bordered, or uses some other attention getting device, for the City to make announcements as-needed of city activity of community-wide interest. This display ad will not appear in the classified section.
