## Fair Housing Counseling & Education

**Alameda, Berkeley, Concord, Hayward, Livermore, Monterey, Oakland, Pittsburg, Pleasanton, Salinas, San Leandro, Seaside, Union City, Walnut Creek, Alameda, Contra Costa & Monterey County**

ECHO Housing investigates reports of housing discrimination, complaints, conducts rental audits and provides educational workshops to tenants and property owners.

## Tenants Rights Counseling & Mediation

**Alameda, Concord, Hayward, Livermore, Monterey, Pittsburg, Pleasanton, Salinas, San Leandro, Seaside, Union City, Walnut Creek, Alameda, Contra Costa & Monterey County**

ECHO Housing provides information and mediation for tenants and property owners/managers. The primary objective is to build awareness of housing laws to preserve Housing.

## Rental Assistance Program (RAP)

**Alameda County Only**

ECHO Housing assists renters with delinquent rent or security deposit due to a temporary financial set back. RAP helps by arranging repayment between the tenant and property owner. Assistance is provided as funding becomes available and tenants are eligible.

## Home Buyer Education

**Alameda County, Contra Costa County and Monterey County**

ECHO Housing assists potential homebuyers by providing individual and classroom training regarding credit counseling, homeownership incentives, home buying opportunities and predatory lending.

## Pre-Purchase Counseling

**Alameda County, Contra Costa County and Monterey County**

ECHO Housing assists potential homebuyers by providing one-on-one counseling regarding credit counseling, homeownership incentives, home buying opportunities and predatory lending.

## Shared Housing/ Homeseeking

**Livermore and Pleasanton**
