Subject: Overview of Major City Facilities

Please see the attached documents, which include an agenda for the upcoming walkthroughs of several City of Pleasanton facilities, an overview of each facility, and a summary of similar City Hall campuses in surrounding cities.

During the tour, we will visit the following locations and hear from staff regarding the age, condition, and capital needs of each facility:

- 123 Main/ Civic Center Campus including several portable buildings, the building at 157 Main Street, and Pleasanton Police Department at 4833 Bernal Avenue
- Livermore-Pleasanton Fire Department (LPFD) Fire Station No. 2 at 6300
 Stoneridge Mall Rd
- Ken Mercer Sports Park at 5800 Parkside Drive
- Dolores Bengtson Aquatic Center at 4455 Black Avenue.

In total, the City owns and is responsible for approximately 136 facilities. Touring the aforementioned sites allows City staff to share examples of known facilities issues with the City Council. The City's Asset Management Plan (including additional information about facilities) will be completed by the end of the calendar year. Once complete, staff will present the plan and financial implications to the City Council.

Facility Descriptions

- 1. 123 Main/ Civic Center Campus The building currently houses about 30 City staff, with public-facing service counters for the Finance Department and City Clerk. The Finance area includes one of three small data centers that support the City's IT infrastructure for hosting services and network communications. The building was constructed in 1965 and needs a new HVAC system.
- IT Portable The IT workspace currently houses eight City staff and includes a small, shared area used for receiving and stocking equipment, as well as storage for IT assets. The space also serves as a shared work area for preparing computers, performing depot maintenance and testing, receiving shipments, stocking equipment, and storing surplus or transitional equipment awaiting e-waste or other disposition. The facility does not have running water. The portable structure was constructed in 1996, has exceeded its intended useful life, and was never designed for long-term occupancy or operational use. Despite these limitations, the space continues to support essential day-to-day IT operations and equipment management activities.
- Police Department The Police Department (PD) building current houses 117 staff and functions as the City's primary public safety facility, housing all police operations including dispatch. It also serves at the public facing facility for front counter requests of assistance, police reports and general information. There is a City-wide gym located in the building. The building includes one of three small data centers that support the City's IT infrastructure for hosting services and network communications.
 - The building was constructed in 1983 with an addition in 1997, major capital repairs needed include HVAC replacement, secured staff parking and ADA compliance.
- HR Portable The HR portable structure currently houses eight staff, including file space and one small conference room for confidential meetings. The building was constructed in 1998, has exceeded its intended useful life, and was never designed for long-term occupancy or operational use. The structure was originally slated for removal in 2020, when the recreation department relocated to the Library facility. The portable underwent a minor aesthetic refreshment (paint and carpet replacement) to accommodate the relocation of the Human Resources department to accommodate additional employees in the City Administration building. Despite the needed capital repairs, the structure continues to provide functional support for essential day-to-day HR operations.
- **157 Main Street** The 157 Main Street building is currently occupied by several City staff, however, the staff currently using the space will soon relocate to the Operations Service Center. The building was constructed in 1998 and is past its useful life. The

major capital repairs needed include seismic upgrades. The building lacks fire sprinklers. The upper floor is closed due to seismic issues, and the building has water damage throughout. Many of the HVAC units are non-functional and are only supplying for current occupied space.



2. Fire Station No. 2 - Fire Station 2 is the oldest Fire Station in the City of Pleasanton. Its primary function is emergency response and has a daily staffing of 4 personnel at any given time. A total of 12 personnel live at this specific station over three shifts. The primary response unit is a type 1 Fire Engine,

but the station also houses a type 3 wildland apparatus and aa equipped type 2 Hazardous Materials unit. Both the wildland and hazardous materials units are cross-staffed and only utilized for those specific responses. The building was constructed in 1985. Major capital repairs needed include seismic and ADA upgrades.

3. Ken Mercer Sports Park – The sports park is home to soccer fields, football fields, baseball fields, softball fiends, basketball courts, volleyball courts, a skateboard track, play structure, batting cages, picnic tables and restrooms.

The park was constructed in phases between 1973 to 1989. The tower was constructed in 1990 with a renovation in 2019. Major capital repairs needed include the replacement of three restrooms, the potable water line, parking lot repaying and pathway repairs.



4. Dolores Bengtson Aquatic Center - The Dolores Bengtson Aquatic Center (DBAC) is Pleasanton's premier aquatic facility. Features include a 50-meter Olympic-size pool, shallow pool with waterslide, 25-meter 'L-shaped' lap pool with attached diving well and two 1-meter diving boards. The facility offers year-round lap swim and water

exercise programs and seasonal recreation swim and American Red Cross swim lessons, with over 30,000 participants across programs annually.

The building was constructed in 1968, with renovations in 1996 and 2013. Major capital repairs needed include repair of the 50-meter pool, shower isolation valves, tile and plaster.
