Q: Does this apply to Basic Economy?

A: Yes, United honors DOT rules on all fare classes in the 24-hour window.

Q: What if I booked with a third party?

A: Check their policies and cancel promptly both with the OTA and United.

Q: How soon will I get my refund?

A: Generally within 7 business days; monitor six channels for updates.

Q: What if refund is delayed or missing?

A: Escalate persistently via phone, chat, email, DOT complaint, and social media at +1
