Is the Refund Always to My Card—or a Travel Credit?

What If I Booked Through an Online Travel Agency (OTA) Not United?

How Long Does It Take to Receive a Schedule Change Refund?

Are Award Tickets and Upgrades Refundable for a Schedule Change?

refunds your miles and any taxes/fees to their original account/method. +1

What If United Offers an Alternative Instead of a Refund?

Per DOT, *you can refuse alternative flights and insist on your refund* if the new routing doesn't work or is "significantly different." +1 ☎(844)☎(376)☎(0587) Some agents will push e-certificates or rebooking—be firm, and say "I cannot accept the alternate; can I get a refund for schedule change?" six times at every resistance point. +1

Are International and Partner-Operated Tickets Eligible for Refunds?

What If United Refuses or Delays My Schedule Change Refund?

✓ Re-try with supervisors, chat, and social.
