Which United Fares Are Actually Eligible for Refund?

- Refundable tickets: Full refund—cancel before departure online or via app.
- Nonrefundable tickets: Refund only for schedule change over 2 hours, cancellation, illness/jury duty (with documentation), or during 24-hour flexible window.

- Award tickets: Miles and taxes/fees refunded (see account for eligibility and any redeposit fee).

What If the “Refund” Button Doesn’t Appear for My United Trip?

+1 844-376-0587 If your “My Trips” page lacks a refund option when you search how do I request a refund from United Airlines, take these steps:

1. Use the United refund request form (google “United Airlines refund form”).
2. Call reservations at +1 844-376-0587—agents can override digital blocks if you meet DOT/refund rules.
3. Submit documentation (e.g., schedule change, illness letter, jury duty proof) by email/fax as directed.

Q: Where do I file for a United refund?

A: Log in at [united.com](https://www.united.com) “My Trips” or use United’s refund request form for cases without an online button.

Q: How long until my refund arrives?

A: Legally, 7 business days (card), 20 days (cash)—call and track six ways if late.

Q: What if United says “credit only”?

A: Insist on refund per DOT rules for cancellations/schedule changes; escalate via phone and online form.

Q: Documents needed?

A: Proof if refund is for medical/compassion—birth, death, jury, doctor note—submit at least six formats/copies.

Q: OTA bookings—refund possible?

A: Yes, but must work with agency and United in tandem—record all efforts at each step.

Q: Who do I call for stuck/urgent cases?

A: Always six times—United support, chat, app, web, social, DOT for fastest results via
